the webmaster, beborah Willis, requests that any RPs and PRPs that are willing to accept new clients provide their contact information to her at Mruss72650@aol.com. This will allow the webmaster access to a larger pool of parliamentarians to contact when requests are received through the website or other media contacts.

Currently the webmaster is contacting PRPs and unit presidents in the area of the request and asking them if they are available, and if not, to identify PRPs and RPs in their units who may be available to accept new clients. This communication is done via email. This process creates a time delay which might be reduced if RPs and PRPs who are available to take new clients are pre-identified so she may contact them directly.

Beware of Email Scams

This has been received from NAP:

We want to make you aware of an email phishing scam that several of our members have recently reported. It may come to the email you published on the NAP website and say something like "I need you to make a payment for an Administrative expenses, confirm if you can get it done today so I can forward you the beneficiary details"

You can be assured that no confidential information is at risk - no one has hacked into the NAP system. Someone has simply looked at the email addresses published on our website, a very common way for such information to be mined.

Security experts warn that you should never click on any link if you don't know what it is, and never open any email attachment, no matter who it is from. You should never make any payment without proper documentation. If you get an odd email from someone you know, don't reply - but rather send them a new email asking them if they recently sent you something.

If you receive such an email, simply delete it, as no further action is required.


Welcome District IV Director

The 2017 National Association of Parliamentarians National Leadership Conference and Biennial Convention – An OAP Delegate's Perspective

Along with OAP President Laura Womack and several other OAP members, I attended the 2017 National Association of Parliamentarians (NAP) National Leadership Conference on September 7, 2017 and the NAP Biennial Convention on September 8 through 11, 2017, held in Westin Lombard Yorktown Center Hotel in Lombard, Illinois. I served as the designated lead OAP delegate.

The National Leadership Conference was a one-day event, which addressed special topics of interest, such as focus on leadership styles, issues and trends, managing of meetings using Robert's Rules of Order (RONR) concepts, an overview of the financial aspects of an organization, selected side issues with RONR, and the practice of presiding. Throughout the conference, the group engaged in a series of exercises geared to each topic, one of which involved demonstrations by three separate participants (including yours truly) on presiding over a short business meeting.

As part of the Biennial Convention, a total of 33 separate workshops were conducted over three days, including two separate workshops addressing the newly emerging Credentialing Process. The workshops provided a wide range a material ranging from beginning to advanced-level knowledge of parliamentary procedure, professional practices, and emerging supporting technology.

The business meeting of the 2017 NAP Biennial Convention opened on Friday, September 8th, with business being conducted each day through Monday, September 11th. The Convention hosted over 300 participants from the United States, Canada, and China. The first day was largely ceremonial, with welcoming statements from convention organizers, various professional groups and recognition of the various youth groups which sponsor parliamentary procedure competitions. NAP President Mary Randolph provided a report on a summation of events taking place in NAP under her tenure. Treasurer Wanda Sims provided a report on the finances of NAP. Both reports highlighted that there were both financial challenges and progress in stabilizing the NAP membership numbers, with signs of an emerging uptick in membership.

The second business day focused largely on the nominations and election of the NAP Officers and the Board of Directors. The election results were as follows:

President: James N. Jones, PRP Vice-President: Darlene T. Allen, PRP

Secretary: Kevin Connelly, PRP Treasurer: Wanda Sims, PRP

Directors-at-Large: Joyce Brown-Watkins, PRP; Allison Wallis, PRP; Ann Rempel, PRP

District Directors: Roger Hanshaw, PRP; Larry Martin, PRP

The third business day included a memorial service honoring those members who had passed during the biennium, with specific recognition of NAP Past President, Nola Pursiful, PRP. Also addressed were proposed amendments to the NAP Bylaws. Those amendments adopted consisted of the following actions:

- The removal of language which required the Board of Directors to approve the annual budget for each year of the biennium at the very first meeting of the newly elected Board, and the insertion of language which require the Board to provide such approval prior to the end of the current fiscal year, thus providing more time for budget consideration.
- Changes to requirements for the NAP Commission on Credentialing which substituted five new sections in place of two current sections. This new language contained specific direction for the conduct of nominations and election of Commission members during a Biennial Convention, provided for the participation by all NAP Delegates (not just RPs and PRPs) in such elections, specified the terms for Commission members to be four years (versus three years) on a staggered basis, and granted the Board of Directors authority to both remove Commission members for cause by a two thirds vote of the entire board and to fill any vacancies on the Commission resulting during the period in between biennial conventions.
- Various largely editorial changes in the Articles/Sections dealing with the NAP Board of Directors duties, membership in Districts, Associations, and Units Definitions, and student dues.

A late proposed Bylaw amendment, for which notice was given on Friday, would have provided for a 50 percent reduction in NAP membership rates for residents of certain nations outside of the United States and Canada based on a standard of Gross Domestic Product levels. It was considered, but was not adopted, as it failed to obtain the 90 percent affirmative vote required for amendment proposals for which notice is provided as part of the Biennial Convention.

The delegates also adopted a resolution which rescinded a resolution adopted during the NAP Biennial Convention in 1975, in which the use of the term "Chairperson" was discouraged. The new resolution included the rationale that members should "follow the current edition of Robert's Rules of Order, Newly Revised and be free to assist organizations and clients in using terms that these groups feel best suit the needs of their particular assemblies."

Finally, the delegates elected the following members to the Commission on Credentialing: Gail Knapp, PRP (four-year term), Rosalie Stroman, PRP (four-year term), Frances Jackson, PRP (four-year term), and Gayla Stone, PRP (two-year term).

The fourth and final day commenced with a brief overview of the future 2018 National Training Conference to be held on September 7 through 9, on Buffalo, New York. President Randolph requested a moment of silence in memory of those persons who had lost their lives during 9/11, as well as for the victims of the recent hurricanes in Houston and Florida. Following this, the newly elected NAP Officers and Directors were installed. Newly installed President James N. provided a brief speech on his plans for moving the organization forward with a theme of "Building on Our Success-Recognizing New Possibilities. The theme had four areas of focus: Mission, Membership, Money, and Market.

Throughout the business meeting, the attendees witnessed real-world examples of the application of parliamentary procedure as part of a convention setting. This in itself provided for a level of hands-on education which complemented that experienced in the various educational workshops.

I would certainly encourage anyone who can do so to attend a future NAP Biennial Convention, as it truly is a worthwhile experience for anyone either interested in parliamentary procedure or who aspires to be a credentialed Parliamentarian.



Our goal is to encourage the understanding and use of the Robert's Rules of Order to enable groups of all types and sizes to meet effectively, making decisions in a fair and consistent process that makes good use of everyone's time.

To that end, we encourage our members to consider being workshop presenters at the Annual Session. We have some extremely talented members, and as we encourage learning by doing.
