

Message from the OAP President

Happy New Year to all OAP Members! Boy, did 2019 go fast, with a lot happening on all fronts. With that in mind, let us do a quick OAP Year-in-Review.

First, OAP made great strides in moving into the video communications and digital meetings world, adopting the Zoom Video conference platform and making it available for use by the Executive Board, Ohio Units, and statewide in general. Both the Board and the Units took immediate advantage of the tool, applying it for their perspective meetings, training sessions, and also for use in preparation for the NAP Registered Parliamentarian written examination.

Speaking of the latter, 2019 was the year where the RP Exam was to move from the longstanding 5-part written test to a new three-part test and demonstration approach. Because of major concerns raised by OAP members (and other NAP members overall) regarding difficulties with the transition, a resolution was passed at the NAP National Convention in Las Vegas in September requesting the reinstatement of the 5-part written test (which was originally phasing out last August). That led to the NAP Credentialing Commission voting to temporarily reinstate the 5-part test as one option to obtain the RP credential, at least for the near term. Several OAP members are taking advantage of this flexibility in dedicated study toward taking the 5-part test in the next few months.

The Ohio Association of Parliamentarians hosted the 50th Annual Session on Friday, April 26 at the Hillside Church of God in Springfield. Supported by the Miami Valley Unit, the Annual Session theme was "Building Your Parliamentary Toolbox", and showcased five major workshops, all geared to the elements of processing a motion. The Annual Session also paid tribute to the memory of the late Henry Martyn Robert III, storied Parliamentarian and member of the authorship team of Robert Rules of Order, Newly Revised.

The high point of the year was the NAP Biennial Convention at the Westgate Resort in Las Vegas, Nevada, on September 5 through 8. Nine OAP Members, along with yours truly, attended the event, which consisted of the business meeting, various educational workshops and seminars, special informative side meetings (including a discussion of the Credentialing Process status), and other social events. OAP members actively participated at the Convention, particularly as either OAP or Ohio Unit delegates to the business meeting, which included election of NAP Officers and Directors to the Executive Board and Members of the Credentialing Commission. One OAP Member, Ed Magiste, actively campaigned (sadly, unsuccessfully) for a seat on the Credentialing Commission. Ohio should be proud of the efforts of the OAP attendees at this year's Convention.

Looking forward to 2020, OAP will be hosting their Annual Session in the Columbus Area, at the Mt. Carmel School of Nursing. This will be a two-day event, held on April 17 and 18, and includes the election of officers for 2020-2022, as well as a great assortment of parliamentary workshops.

There will also be a series of educational workshops presented on April 18 specifically geared to attendees from the general public. Additional details are provided in this issue of the Parliagram. Also, stand by for several Unit-based events during Parliamentary month in April.

WHAT WE TEACH and HOW WE TEACH— Patricia A. Koch, PRPPresident, North Coast Unit

During my years as a Professional Registered Parliamentarian, I have had countless opportunities to teach others about Parliamentary Procedure. Those of you who know me well also know that I was a mathematics teacher and had classes at all levels, elementary, junior and senior high school and university. Parliamentary Procedure and Mathematics--two subjects very far apart in content, but so close in methodology. I've learned that each subject begins at the beginning, each has important topics that must be done in sequence, and each one has constant mystery!

Last year I had opportunities to teach these parliamentary topics: minutes, order of business, committees and their reports, the duties of various offices, bylaw amendments. There were also the great experiences with those preparing for the Registered Examination and the young men and women at Buckeye Career Center, East Holmes campus who were the Parliamentary Team which placed 10th at the National BPA Parliamentary Competition in California.

During and after adult sessions I am always thanked for my presentation. The young men and women at Buckeye took time to write letters to me from which I pulled the ideas which will anchor the rest of this article.

This was my first time attending and observing an actual meeting of parliamentarians following Robert's Rules of Order Newly Revised Eleventh Edition."

"I am very grateful for your invitation to the Ohio Association of Parliamentarians Annual Meeting. It was a very beneficial day for our whole team. The workshops, as a whole, presented ideas we already knew but refreshed us in our knowledge of the subject and assured us that we were doing things the right and correct way. The Workshop on Incidental Main Motions was extremely worthwhile to me. At my stage in Parliamentary Procedure I find those motions one of the most confusing things in the whole procedure. After that day our team just had a fresh start, and we were much more confident in our knowledge of what we were doing."

"Throughout the day at your annual meeting, I enjoyed taking my knowledge of Parliamentary Procedure to the next level. The workshop in which I learned the most was "Governing Documents." Prior to this, Bylaws, Charter, etc. are categories I have not studied in depth, and that workshop was very helpful to me. I also gained insight from the other two workshops I attended; "Order of Business" and "Incidental Main Motions." These are basic knowledge categories to me, but it was helpful in that I got a good refresher, gained new ways of remembering and memorizing parts of it, and learned some new things I had not discovered before".

What We Teach—the first part of my title, is so important. At unit and state meetings, include some of the basic topics but make sure to offer a more indepth approach to the content.

Include topics that are challenging, perhaps, for some, the first time learning it. In both types of content-basic or challenging—take the presentation to a next level. When teaching the public, we usually know the topics they want, so the challenge is to make the presentation interesting and include time for the audience to ask questions and engage in conversation about the content.

How We Teach—the second part of the title, is even more important. Yes, even more important than RONR whatever the edition! How to teach includes having the materials, activities, and questions to be addressed. The most important element, however, is you, or me, or us! In every letter I received from the students it hit home to me that my success as an educator involved my ability to listen! That I listened to their questions, restated them if necessary, gave answers and rechecked--did I answer what they asked?

Some additional suggestions--:

• Assure your audience they are doing things the right and correct way when they are and help them understand the differences between the correct and incorrect ways.

• Give advice and guidance when asked for it. This usually comes about when we are presented with the dilemma the person is facing.• Try to clear up confusions about certain topics.

• Answer questions, deal with mistakes, and bring your "students" to a higher level of knowledge and expertise.

CALL TO ANNUAL MEETING!



You are invited to attend the 2020 Annual Session of the Ohio Association of Parliamentarians on April 17 and 18 at the Mount Carmel College of Nursing, 127 S. Davis Avenue, Columbus, Ohio 43222. The activities will begin both days at 8:30 AM. Friday's session will include a business meeting which will include nomination and election of officers for the 2020-2022 administration. Lunch will be provided as a part of your registration fee, as will refreshments both days. The session will end by 1:00 PM Saturday.

There will be several educational sessions as well as a guest from the National Association of Parliamentarians who will update us on the organization and provide an educational opportunity. Materials from NAP will also be available for sale.

As planning is still ongoing, watch your email late February or early March for an update of workshops and other happenings related to the event. There will be door prizes and fund raisers. In addition, at the request of the Columbus Ohio Parliamentary Unit, the Ohio Association of Parliamentarians has approved a special Public Day for the Saturday Session. Non-members attending only the Saturday Session will have a special admission of \$15 per person or \$20 for two if the two are from the same group, organization, or are attending together. This is an effort to increase the membership of OAP and to increase interest in parliamentary procedure.

There are many hotels in Columbus with varying prices. The closest hotels to the venue are near Ohio State University or downtown. Hotels near I-670 are a short drive away. Columbus has a lot to offer from shopping, to theater, to great restaurants. And is the home of the world's largest gavel.

Website and Social Media Updates

OAP has seen a lot of online activity, including updates to the website, investigation of social media opportunities, and the study and implementation of electronic meeting capabilities.

Website Updates:

Our home page, http://ohioparliamentarians.org, is now updated to show new members and new certifications. It will shortly be updated to include the registration form for our Annual Session, April 17-18 in Columbus.

Social Media Opportunities:

At their January meeting, the OAP Board of Directors discussed possibilities for social media involvement. Parliamentary consultation is a professional service, and so it seems that one of the first social media sites we should investigate is LinkedIn. We'll use the Parliagram to provide updates on OAP's social media presence.

Electronic Meetings:

As Parliamentarians, we know that the use of electronic meeting capabilities for deliberative groups needs to be carefully considered in order to meet the requirements of RONR. However, those considerations don't apply to trainings, which are not deliberative assemblies. Since early August, our Zoom Pro account has been used for 77 sessions, most of which are training's. We have two groups meeting with Zoom: one reviewing for the NAP Membership test, and another for the Registered Parliamentarian test. We're grateful to Patricia Koch, PRP, for conducting those training sessions.



Every Zoom session needs to be initiated by a "Host." We have been fortunate to have four working hosts who have facilitated Zoom sessions: Dorothy Gordon; Bill Lavezzi; Myra Myers, PRP; and Nancy Terpening, RP. They've worked very hard to help our units, members, and member prospects use this asset, but we need more hosts. We'll be training some new hosts on Saturday, January 25, 2:00-3:30 PM.
